





# **Board Spotlights**

#### JOHN KLEIN

Alongside Msgr. Bob McDermott, John launched Joseph's House in 2010 as a temporary facility that offered food and shelter during winter months.

Two years later as Executive Director, John moved Joseph's House to its current location, with cots (rather than floor pads) and year-round operations.

Next John brought to fruition his vision for day services with case management, employment services, and a health clinic.

Then in 2019, John announced plans to expand Joseph's House into adjoining space to welcome even more guests, and offer dining and storage space.

John then transitioned from executive director to board member, where he shared the knowledge he'd gained on the issue of homelessness and was a strong advocate of the right programs for our guests.

"John's involvement on the board at Joseph's House was part of our success. His spirituality and compassion have been a driving force in all he does. He is a good person who speaks, acts, and stands up for the truth."

"In 2009, Father Bob suggested we add Dominic to our 'gang of thinkers.' Dom was clear that he would help but did not want to get too involved, which was evident when he became our first Board Chair and stayed until 2022!"



#### **DOM VALLONE**

Another soldier in the army of Msgr. Bob McDermott, Dom was the first Joseph's House Board Chair.

He set out on his mission in 1976 after hearing a presentation by Mother Teresa that would change his life. Next, he and three other young Camden residents formed the Cathedral Kitchen with the goal of helping the hungry of Camden.

After that came the vision of Joseph's House, and Dominic was there. He was an active board member from the early days until December 2022. In that time, he held many roles, including chairperson and volunteer. Dom is presently active on the facilities committee.

Dominic has always had a compassion for those experiencing homelessness. Joseph's House is grateful for his expertise and love for our mission.

## **Homelessness in America**

Every year, the **U.S. Department of Housing** and Urban Development (HUD) oversees the Point-In-Time count across the last 10 days of January. As of the 2022 count: **582,462** 

#### Individuals\* were experiencing homelessness

a relatively flat number (+.3%) from 2020

# ~30% of those are experiencing chronic homelessness

they've been without homes for more than 12 months or have experienced periods of homelessness over the past three months

#### 60% are sheltered in facilities

#### 40% are **unsheltered**

The percentages of both are growing:

- Chronic up 16% over the past two years
- Unsheltered up 3% (up 5% among women and girls)



# **Public & Government Funds**

#### Q. How do local, state, and federal governments allocate money to non-profits?

A. Just like they do for paid services/purchases, a government entity will announce a Request For Proposal, looking for a vendor to provide a charitable service.

After the entity collects and reviews all the proposals submitted by the non-profits, they will grant the funds to one or more and collaborate with them as needed.

At Joseph's House, our practice has always been to ask for just the funding we need – no more, no less.

Our accomplishments over the past decade speak for themselves. We have

proven our ability to make ends meet while also contributing to operational growth and return-to-housing success for our guests.

But we also maintain a skilled and experienced staff, so we are smart about how we divvy up the money we receive.

Until early 2023, Joseph's House did not receive any government money that we didn't apply for.

#### What's changed? PROVEN COMMITMENT AND RESULTS

Our results shine brightly in the government reports we're required to submit:

- How close to capacity we are operating
- The kinds of support services are we offering
- How many guests receive case management
- What the outcomes are for our guests



These days government agencies are asking us, "How would you use a few more dollars?"

### **Public & Government Funds**

#### NJ DEPARTMENT OF COMMUNITY AFFAIRS (DCA)

Over the years, the DCA has provided funds for facility upgrades including heating, air conditioning, roofing, windows, and restroom renovations.

Most recently, we invested the capital coming from DCA into secure fencing and gates, exterior paint and waterproofing, and marquee and canopy. "These upgrades not only add value to our property and increase the safety of our guests and staff, but also, they give us all a sense of pride to be associated with Joseph's House and invite others to join us."

# **Business & Faith Community Partners**

Cathedral Kitchen is the largest emergency meal provider in South Jersey, serving more than 150,000 nutritious meals annually for food-insecure residents of Camden and the surrounding areas.

They also serve as a liaison to help people in the community get the care they need.

That includes referring their guests experiencing homelessness to Joseph's House for shelter, showers, and other services.

Conversely, Joseph's House has referred guests to Cathedral Kitchen's free culinary arts job training program and has hired many its graduates.

For the past six years, Cathedral Kitchen has generously provided the Friday evening meal for our guests.

And thanks to funding from the Connelly Foundation, Joseph's House has contracted Cathedral Kitchen's catering services to provide a special surf and turf holiday dinner for our guests with all the traditional sides.

Joseph's House cherishes our partnership with Cathedral Kitchen. We share a similar mission to provide low barrier services to people struggling in our community. Prioritizing our guests' needs,

we consult one another for ideas and advice when developing policies and protocol.

They have supported us through dozens of hours of volunteering, as well as grants to support our capital campaign and to underwrite the **Social Worker** position.


Our relationship with Subaru is a true partnership, and they have come to trust our commitment to providing judgment-free safety, food, and support for our guests.
